The Court makes the following findings and orders:

Findings:

1. California is the home state for Oliver Lally-Roepke (DOB 6/30/95).
2. The parties were present in Court on December 16, 2008 and participated in the hearing.
3. The parties have been advised that violation of the Court's orders may be punished by civil and/or criminal penalties.
4. The USA is the country of habitual residence for Oliver.

Orders:

5. The mother and the father shall each take Oliver to Dr. Doyne's office in order for Dr. Doyne to interview Oliver. The parties are ordered to cooperate with Dr. Doyne.
6. Minor's counsel shall provide Dr. Doyne with a copy of all pleadings filed by the parties since October 14, 2008.
7. Dr. Doyne shall review minor's counsel's report filed on December 4, 2008. Dr. Doyne shall comment on minor's counsel recommendations.
8. Dr. Doyne is authorized to speak with Oliver's therapist, Dr. Chris Miller.
9. The father shall pay 2/3 of Dr. Doyne's retainer. The mother shall pay 1/3 of Dr. Doyne's retainer. The Court shall reserve jurisdiction over the issue of payment of Dr. Doyne's fees. The parties are ordered to file Income and Expense Declarations by January 9, 2009.
10. All existing orders shall remain in place pending the completion of Dr. Doyne's report.

 - a. The father is ordered to pay to minor's counsel the sum of \$2,418.75.
 - b. The mother is ordered to pay to minor's counsel the sum of \$806.25. The mother shall make payments to minor's counsel at the rate of \$200/month commencing on January 1, 2009.
 - c. The Court shall reserve jurisdiction over the issue of minor's counsel fees.
12. Minor's counsel shall prepare the order and submit it to counsel for approval with a conformed copy being mailed to the mother.
13. The matter shall be reviewed on January 15, 2009 at 9:00 AM.
